# Entry Requirements & Prerequisites

To become an approved SIFI in Victoria you are required to demonstrate a minimum of 12 months working experience as an Armed Guard officer and have the following current qualifications:

- TAE40116 Certificate IV in Training and Assessment
- CPP31318 Certificate III in Security Operations (AG / CIT)
- HLTAID011 / 014 Provide first aid or Provide Advanced First Aid
- Private Security Individual Licence with activities of:
   Armed Guard / Cash in Transit / Trainer
- Victorian General Category Handgun Licence

Technical Advanced Training can guide and assist you in applying to add the Trainer Activity on your Private Security Individual Licence to the Licensing and Regulation Division (LRD) – Victoria Police

In addition to the above you will be required to go through the institutes Language, Literacy and Numeracy process. This is to ensure you have the skills required to successfully complete this training.

# Literacy Language and Numeracy

Assistance and support will be provided with Literacy, Language and Numeracy issues.

#### Assessment

Students will be required to be assessed in this program to demonstrate they have achieved the skills and knowledge set out in the SIFI course.

Your competency is based on five (5) key assessments: Closed book exam, Practical shoot evaluation and three (3) assessment deliveries with each assessment delivery containing a lesson plan.

#### **Resources & Facilities**

Existing and prospective SIFI trainers will be provided with the required learning resources. All applicants are required to bring their own duty equipment, industry approved handgun (Revolver and or Semi-Automatic), ammunition (min 300 rounds for each handgun) and personal protective equipment (ear and eye wear – ballistic rated). Classes will be conducted as required in an appropriate learning environment. We recommend you bring a clipboard and an exercise book to keep track of your learning.

If you do not have access to a handgun and or ammunition, TAT can source you a handgun at an extra cost of \$200 for day and ammunition will cost \$500 for 600 rounds.

Note: TAT only uses factory made ammunition.

## **Completion Requirements and Duration**

To achieve the qualification applicants must have demonstrated competency in five key assessment areas:

- ASSESSMENT 1
   Closed Book Exam
- 2. ASSESSMENT 2 Lesson Plan 1 In Class Demonstrating a Firearms topic
- 3. ASSESSMENT 3 Lesson Plan 2 In Class, Demonstrating a Shoot
- ASSESSMENT 4
   On Range, Practical Shoot Evaluation
   (Minimum pass score is 256 out of 300)
- ASSESSMENT 5 Lesson Plan 3
   On Range, Teaching a Practical Shoot

Providing you satisfactorily meet the entry requirements and prerequisites the Security Industry Firearms Instructor (SIFI) course will then run for:

- 5 days for new applicants and
- · 3 days for an annual SIFI requalification.

All training is delivered Monday to Friday. In addition to the face-to-face classroom learning you will need to commit to approximately 3 hours each day of study/revision through the training to complete the assessments of the SIFI course.

This is a competency-based training.

Attendance alone is no guarantee of certification.



#### **Course Fees & Charges**

The SIFI training will cost:

- \$1600.00 for new applicants
- \$1100.00 for an annual regualification

This price includes workbooks only.

Full fee upfront payment is required prior to course commencement. All cancellation requests made prior to course commencement date will incur a \$150.00 administration fee. Once courses have commenced, the organisation will not approve refunds or transfers under any circumstances.

Technical Advanced Training reserves the rights to cancel or postpone the course commencement date with low enrolment numbers up to two days prior to the course commencement date. Should a course be cancelled or postponed, you will be notified either by mail, telephone or email. Cancellation of a program by Technical Advanced Training will result in a full refund.
